The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Certain funeral services may be provided off-premises by other funeral service providers.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff, and Overhead \$2,895**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.

This fee includes, but is not limited to, funeral director and/or staff to respond to initial requests for services; an arrangement conference with family members and responsible parties; coordination of service plans with the cemetery, crematory, medical examiner, and others; recording and filing of death certificate and disposition permit; assistance with the placement of obituary notice; and care and custody of decedent until final disposition. Also included in this charge are overhead expenses related to our facilities such as professional licensing, legal and accounting services, insurance, building and utility expenses, parking and grounds maintenance, taxes, equipment, furnishings, supplies, record-keeping, and administrative support.

**Preparation and Care of the Deceased**

Embalming.....\$1595

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. *In accordance with Virginia law and our funeral home policy, we require that a decedent be either embalmed or placed under refrigeration within 48 hours of death.*

**Forwarding of Remains to Another Funeral Home \$4,095**

Our charge includes: a proportionate share of basic services of funeral director, staff, and overhead; transfer of decedent to funeral home (within a 25-mile radius); preparation of remains; and local transportation to airport (within a 25-mile radius). This charge does not include visitation, rites, or ceremonies.

**Receiving of Remains from Another Funeral Home \$3,095**

Our charge includes: a proportionate share of funeral director, staff, and overhead; transfer of decedent to funeral home (within a 25-mile radius); sheltering of remains; and local transportation to cemetery (within a 25-mile radius). This charge does not include visitation, rites, or ceremonies.

**Direct Cremation \$2,995 to \$14,590**

Our charge for a direct cremation without ceremony includes: a proportionate share of basic services of funeral director, staff, and overhead; transfer of decedent to the funeral home (within a 25-mile radius); refrigeration; local transportation to the crematory; filing necessary authorizations; and cremation. This charge does not include visitation, rites, or ceremonies.

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard, cardboard, and select hardwood.
